

**Academic Cooperative Agreement
between
Guangxi Teachers Education University
and
Srinakharinwirot University**

Guangxi Teachers Education University, Guangxi Province, People's Republic of China and Srinakharinwirot University, Bangkok, Kingdom of Thailand are interested in bringing a more global dimension to their curricula and research.

The agreement, therefore, is made as a gesture of goodwill between the two universities and mutual benefit through the cooperative effort in the following areas:

1. Exchange of students for joint degree, and non-degree curricula
2. Exchange of faculty members and staff
3. Exchange of academic materials and other information
4. Joint research activities and publications
5. Joint performance and exhibition activities
6. Participation in seminars/ workshops and academic meetings
7. Participation in special short-term academic and cultural programs


This agreement shall be valid for **five years** from the date of signing. Revision or renewal of this cooperative link is subject to mutual consent of both parties.

It is expected that this agreement will lead to other more specific collaborative agreements between the two institutions. Details of the implementation of any particular activities resulting from this agreement shall be negotiated between the two universities as such specific cases arise.

Either party may terminate the agreement by written notification signed by the appropriate official of the party initiating the notice. Such notification must be received by the other party at least six months prior to the effective date of termination.


This agreement serves as the intention of both parties to work together to promote academic and educational linkage. It does not have any legal binding on the part of the universities involved.

关于辽宁中医药大学与泰国诗琳通大学 学术合作意向书

中国辽宁中医药大学与泰国诗琳通大学在自由及相互平等互惠、相互尊敬的原则下签订学术合作意向书，双方就合作事项确定如下意向条款：

目的

第一条

鉴于多方合作的重要性及高等教育对于人类社会的贡献，双方通过相互增进国际教育和学术研究的交流，相互协作共谋发展。

第二条

此份合作意向的首要目的是为了双方进一步在学术和文化领域的合作交流提供一个基础，双方的合作交流将涉及到双方大学之间的交流和/或双方大学的学生之间的交流。

第三条

鼓励大学之间和各学科的研究人员发展交流并提出合作项目。建议依据所提出的合作项目的优势和资金情况来评估每个合作项目的可行性。双方将发挥各自内部和外部的资源优势就双方的交流合作给予充分的支持，这将是本意向书制定的最终结果。

第四条

一旦双方开展教学或科研等方面的专业合作，双方须另行签署相关的合作备忘录（或协议书），并将列清关于合作项目所涉及到的相关条款和细节。合作备忘录（或协议书）将经由双方相关的行政管理员批准并签署。

一般条文

第一条

所有研究人员和其它合作活动的进行将根据本合作意向执行，本合作意向书是根据双方大学及地方的法律法规和规章制度制定。在辽宁中医药大学执行本意向书时，应根据中国的法律和辽宁中医药大学的规章制度执行；在泰国诗琳通大学执行本意向书时，应根据泰国的法律和诗琳通大学的规章制度执行。

第二条
