



MEMORANDUM OF UNDERSTANDING



Between

Thai Nguyen University of Agriculture and Forestry (TUAF)

And

Srinakharinwirot University, Kingdom of Thailand (SWU)

This Memorandum of Understanding (MOU) is proposed on the day of June....., 2017 between the Thai Nguyen University of Agriculture and Forestry, Vietnam and Srinakharinwirot University, Thailand.

Whereas Srinakharinwirot University is an autonomous comprehensive university located at 114 Sukhunvit 23 Bangkok, Thailand; and

Whereas Thai Nguyen University of Agriculture and Forestry, a leading National Agriculture University in Vietnam, is located on Mo Bach Street, Thai Nguyen City, Thai Nguyen Province, Vietnam,;

The two Parties are interested in establishing a basis of cooperation and have agreed to sign the Memorandum of Understanding as a gesture of goodwill on the terms contained herein.

A. Principle of Cooperation

On the basis of mutual benefit and understanding between **Thai Nguyen University of Agriculture and Forestry** and the **Srinakharinwirot University** will make efforts to develop academic exchange and cooperation between both parties.

B. Areas of Cooperation

- 1) Mutual visits and cooperation of scholars and teachers in training;
- 2) Academic & student exchange and cooperation agreed by both parties;
- 3) Implementing a bilateral study abroad program;
- 4) Exploiting bilateral scholarships;
- 5) Other training cooperation programs as agreed by the two parties.

C. Implementation and Termination

This MOU will come into effect on the day on which it is signed by both parties. It will continue for a period of five (05) years, thereafter the MOU may be extended for a further period by written understanding between both parties.

D. Limitation and Liability

In no event shall either party be liable to other for any damages whatsoever including, without limitation, direct, indirect, speculative, incidental, special, or consequential damages in connection with the performance of this MOU.

E. Modification

No variation, modification, alteration of any provisions of this MOU shall be effective unless made with prior written understanding of the parties.

F. Governing Law and Jurisdiction

This MOU and any final understanding entered pursuant to this MOU shall be governed by and conducted in accordance with the laws of Vietnam and the Thailand. Any dispute, controversy or claim arising out of or relating to this MOU, of the breach, termination, or invalidity thereof, shall be decided and finally resolved by arbitration. The language to be used in the arbitration proceedings shall be English.

This MOU is prepared in English and two (2) original copies of this MOU are produced. Four copies are authentic. As witness to their consent of this MOU, the appropriate authorities here to provide their signatures.
